**INVITATION FOR APPLICATIONS FOR THE POSITION OF ENTERPRISE
DEVELOPMENT FUND (EDF) BOARD CHAIRPERSON AND BOARD MEMBERS**

The County Government of Nyeri has been running the Enterprise Development fund (EDF) which is a loan facility for small business people as outlined in the County Enterprise Development Fund Act of 2017 as amended in 2018.

The County Government of Nyeri invites applications from qualified individuals to fill the positions of members of the Enterprise Development Fund (EDF).

The board is made up of the following representatives;

- i. Representative of the Business Community-Must be a member of a registered business Association in the County
- ii. Youth representative -Must be a member of an active registered youth group/association in the County.
- iii. Cooperatives Representative-Must be a member of a leading cooperative within Nyeri County.
- iv. Persons living with disability (PLWD)-Must be registered with the National Council of Persons living with disability.

Requirements

The applicant must meet the following requirements; -

- Must be a Kenyan citizen
- Holds a diploma (*business related*) from a recognized institution in Kenya
- Has operated a business which is micro and small enterprise in the County for a period of three (3) years.
- Satisfies chapter six of the constitution.

The applicant should not have been; -

- Convicted of a criminal offence and imprisoned for a term not exceeding six months
- A member of a governing body of a political party
- Previously removed from public office for contravention of the provisions of the constitution or any other written law.
- Undischarged of bankruptcy
- Charged to have violated the constitution or any other written law.

Functions of the Enterprise Development Fund (EDF) Board

- a. Formulate sound policies for the administration, regulation and management of the fund,
- b. Set criteria for appraisal of loan applications, approve the disbursement of fund and set loan repayment conditions,
- c. Put in place necessary mechanisms for sanctions and their enforcement in cases of loan repayment default,
- d. Mobilise resources for the furtherance of the objectives of the fund,

- e. Establish and maintain links in need in and outside the County with organizations with similar objectives,
- f. Convene an annual forum for fund beneficiaries for sensitization purposes,
- g. Prepare and submit annual reports on the operations and performance of the fund to the County Executive Committee Member for Trade.
