NATIONAL AGRICULTURAL VALUE CHAIN DEVELOPMENT PROGRAMME (NAVCDP)

Their main objective is to increase market participation and value. They are aiming on increasing produce capacity. This is by finding ways where farmers can have varieties in terms of what they can produce. Assisting farmers to be in a position where they are equipped with more knowledge on what they can put out for sale and not limited to just a few. They also aim at increasing lead farmers by offering extension services. Introduction of technology that will enable farmers to work more efficiently. Grants provided are to help farmer's producer organizations, provide Digital Solutions to Agriculture, Market access and certificate of exports. It was clarified that the farmers are allowed to make groups according to their preferences. The public is free to come up with their own criteria when it comes to formation of groups. It was noted that the main problem affecting the programme is sustainability and input strategy.

AQUACULTURE BUSINESS DEVELOPMENT PROGRAMME (ABDP)

The overall goal of the programme is to reduce poverty and increase food security and nutrition in rural areas. Increasing market potential of the aqua businesses and conducting research that will come in hand for aqua cultural activities.

AGRICULTURAL SECTOR DEVELOPMENT SUPPORT PROGRAMME (ADSP II)

This is a key programme designed by the Ministry of Agriculture, Livestock, Fisheries and Cooperatives. The goal is addressing food and nutrition security and promote manufacturing. It is designed to tackle the problems that hinder commercialization of Agriculture.

LIVESTOCK VALUE CHAIN SUPPORT PROJECT

The objective is to support the development of livestock value chain by increasing the outreach of participating financial institutions to livestock farmers and entrepreneurs.

FINANCING LOCALLY LED CLIMATE ACTION PROGRAM (FLLOCA)

The development project is to deliver locally led climate resilience actions and strengthen the County's capacity to manage climate risks. The goal is building county level capacity for planning, budgeting, reporting and implementation of local climate actions in partnership with communities.

KENYA INFORMAL SETTLEMENT PROGRAMME (KISIP I, KISIP II)

KISIP focuses on the slums. There was a mention on the constituencies covered. There were complains about the 24 title deeds that have not been issued. It was reported that they would be issued since there is a list that is being followed. A question was posed regarding why Kieni East is not involved in KISIP II. It was agreed that the concentration is mostly on the slum areas and Kieni East is not in that category. An issue was raised regarding compensation. It was sorted by explaining the construction of the road has interfered with the process hence the Local Government has to wait for National Government's directives. KISIP II goal is to construct roads, food and water supply, security and sanitation.

KENYA URBAN SUPPORT PROGRAMME (KUSP I, KUSP II)

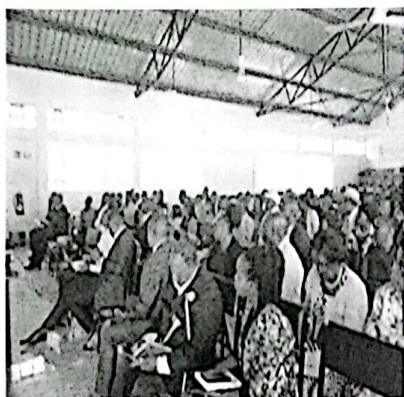
